Lois reviewed the Audited Financial Statement as of June 30, 2023.

The Statement of Financial Position - increase in revenue by about \$60,000 compared to 2022, increase in rentals by  $$^20,000$ 

- professional fees - architect ~\$7,500 for the basement entrance

Auditor's qualified opinion that the financial statements present fairly our financial position as of June 30, 2023 according to Canadian accounting standards for not-for-profit organizations. -Sufficient, all information was readily available and they experienced no difficulties. ## Ministry Update

Pastor Wayne gave a ministry update.

- -To our local community, people who are marginally connected to our church through Food Pantry, Kids' Zone camp. Challenge: to be active in serving the Lord.
- -People of compassion, encourage one another in our faith
- -baptism help those who have been baptized recently
- -live a missional life in our community active in the community to serve continue to provide opportunities to serve maybe with our Life Groups for next year Sermon Series Unleashed for Christ Jesus came to serve not to be served

# Capital Projects Update

- -Recap of the Basement Exterior Entrance Project handout
- -Mark Eggengoor met with latest contractor

- -Council Elder retreat March 2022 repairing the parking lot was a high priority basketball nets safe space, building relationships and getting to know Jesus
- -Howard's estimation  $\sim$ \$50,000 \$60,000 goal to be welcoming and to engage our community and introduce them to Jesus
- -Building permit was approved in September five quotes from Contractors Trustone (Karan) submitted a newer quote  $\sim$ \$48,000 sidewalls might be more decorative, time delay due to the season might bring a price increase

Motion: Heart Lake Baptist Church members approve a \$60,000 budget for the exterior basement entrance, plus a \$5,000 contingency fund.

Ethan: Do we still want to move forward with the entrance? -we can use the stairs - paving of the parking lot should be the only priority

Mark's response - better for the community to enter through the back entrance - should have been in the original design - order of construction is important due to heavy equipment

Hilda - Heartbeat Bikes - for a different purpose - other programs in mind - how much altogether for the pavement too?

Mark's response - pavement quote ~ \$80,000 -brainstorm ideas - think long-term

Online question: Is there still an individual that was supporting the basement - is the donor still there? Response: Not sure

Leandro: Finished basement - is there a budget for that?

Response - will occur later

Lois - Possible uses Food Pantry, gardening workshop, etc.

Forum - dreaming about what we could use the basement's space for - Heartbeat Bikes was only going to be short-term

Monica - mentioned Pastor Wayne's Ministry update - unleashed for Christ: active in the community to serve

Ashton - potential ministries - What is it for? Why?

Hannah - guests - Food Pantry - feels like there won't be any money brought back from it

Adekunle - Fire Drill - direct exit out of the building is very important

Online - Do we need to renovate the basement first?

Mark: you put the doors in first

Adam - unfinished part of the church - basement - will it be completed? will it be beneficial? - look at the project in general - excitement about the project moving forward - clarity - what is the use of the basement going to be?

Daisy - thought this should have been discussed before today - would like to see the pavement done - too many puddles

Lois' response - was discussed at the June meeting last year - approved last year - community coming into the basement - Forums held prior to June meeting last year.

Ethan - limited amount of grass, used for camp, will lose it to the entrance - stairs to the basement - doors with windows - more appealing - instead of digging up some of the property

Lois - let's pray for guidance

- as we have different perspectives secret ballot
- -Pastor Wayne and Louise prayed
- -Steve Lougheed varying view can we delay until we can have time to make this decision Motion to table it

Patti - lots of conflict - is there conflict in the leadership?

Lois' response - no conflict in leadership, majority are in favour

Sue Ott - the vision - be open and to welcome the community - future and outreach directed - our leadership is saying this is part of our vision to move forward

- -Ballots were passed out and members voted yes, no or abstain. Ada Agi and Sue Ott collected and counted the ballots.
- -Pastor Wayne gave credit to all for their participation

## The motion did not pass.

<u>Financial Update</u> - Current Status - Monica presented a financial update from June  $30^{th}$  until now. November Giving Campaign - as of November  $20^{th}$ : \$25,729 goal: \$57,365 Expenses are in line with our budget.

Copies of the October Financial Statements were available

Lois - Explained an exception for Leandro D'Amico approved by council. He has been an active adherent for 10 years, but only became a member officially in May so council made a one-time exception to the one-year member rule to allow Leandro to stand as Elder and Council Member.
